This Agreement summarizes the cooperative roles and responsibilities among the Paleo Partners for the initial phases of the Paleo Project.

### Implementation Plan 2005-2007

This agreement covers the initial implementation of the Paleo Project. Individual partners may amend or update their described roles and responsibilities as needed. The full agreement will be reviewed and updated by the OPLI Board on or before June 30, 2007. (See Attachment A)

### I. Preface

The Paleo Project was the first project in Oregon to be designated by former Governor John Kitzhaber as a highest priority state sustainability project under Oregon Solutions. It won the prestigious Governor's Sustainability Award in 2001. It has won acclaim in local, regional, state and national media through articles that have been circulated far and wide by national news wire services. The Paleo Project played a strong



role in the recent designation of Fossil as a 2003 All America City Finalist in a national competition.

# **Oregon Solutions**

The mission of Oregon Solutions is to develop sustainable solutions to community based problems or opportunities that support economic, environmental, and community objectives simultaneously through partnerships between government, business, and non-profit organizations. Oregon Solutions utilizes a collaborative approach to develop integrated, community-based solutions, bringing all stakeholders to the table, including permitting agencies, funders, and organizations offering technical assistance. In other communities, this approach has helped to leverage investments, expedite the project, break through barriers, identify valuable partners, and elevate the visibility of the project. The final step of the Oregon Solutions process is for all partners to sign a declaration of cooperation or agreement that commits their time and/or resources to the project. The agreement then becomes the mechanism of governance for the project.

### II. Project Description

Largely undiscovered to a mainstream audience and not yet heralded as a major Pacific Northwest attraction, the fossil basin of north central Oregon holds a special place on the planet and a special place across time. The region's rock palisades, colorfully-striped hills, fossilized flora and fauna, petrified mudslides, and ancient timelines preserved in rock strata are all of global importance.

Over the past century these ancient findings have been studied by scientists from around the world who recognize the region's resources as among the world's most clustered, visible geologic history of the age of mammals. To bring these resources to the attention of a much wider audience and to gently stimulate a struggling rural economy by doing so has been the focus of the Paleo Project.

This strategy would begin at the community of Fossil with its public fossil digging beds and, aptly, would radiate out from there. As promotion and understanding of the resources increased, so too would public interest. Increased awareness would trigger more visitors. Increased tourism would benefit local and regional businesses. Oregon itself would have one more message to flaunt: *World-class fossils*, *just three hours from Portland!* 



As visitor dollars circulate, a stagnant economy begins to improve, and a region that has been languishing for too long takes a definitive step forward.

Over the past three years, nearly \$2 million has been invested in local projects that are based on the Paleo Project. These include a summer programs, a three-year community-school education program, architectural planning for a paleo-based facility and infrastructure improvements to the City of Fossil.

National recognition for this region would reflect the direct objectives of the Paleo Project – to draw attention to this region and to benefit from that attention.

To ensure the development of the Paleo Project a series of collaborative agreements are outlined below. These volunteer agreements are intended to demonstrate commitment to the project and delineate to some degree the areas of cooperation among the various parties interest in seeing the Paleo Project become a reality.

Those who sign this agreement and/or the entity they represent will become instrumental in assisting with the planning and implementation of an economic strategy that is clearly part of the revitalization of the economy in a special place in eastern Oregon.

# III. Partners, Roles and Responsibilities

# Oregon Paleo Lands Institute Board

Oregon Paleo Lands Institute is nonprofit established to provide and coordinated public education and related economic development for the unique natural history found in north central Oregon. Board members are well experienced in public process, project development, similar projects and who are knowledgeable about scientific resources in the region and experienced in collaborative efforts.

The Oregon Paleo Lands Institute (OPLI) will assume responsibility for the following:

- Coordinate the efforts of the Paleo Partners in the development, operations, and programs of the Paleo Project.
- Promote the Paleo Project as a viable economic and community development project for the region and State of Oregon, and as a Pacific Northwest destination;



- When appropriate and in conjunction with Wheeler County, the City
  of Fossil and the Fossil School Board, and other partners, the Board
  will provide direct oversight and pursue fund development for
  operations and implementation of the various facets of the project,
  including staffing programs, facilities and outreach;
- At the appropriate time own and manage the learning center facility;
- Manage and/or contract the learning center's outreach efforts and program development across the region;
- Develop and maintain adequate budgets for operations and programs;
- Assure representation on regional and statewide educational, economic development, sustainability and tourism organizations;
- Serve as one of the voices for natural resource partners of the region and as a strong partner on statewide natural resource needs and issues; and,
- Serve as a centralized educational clearinghouse, repository, and distributor for natural history information for north central Oregon and for state, federal and private partners who desire a presence in eastern Oregon.

### **Fossil School District**

The Fossil School District and its Board of Directors represent the interests of the Fossil School District and the taxpayers who support the school district. Fossil School District presently owns the land occupied by the Wheeler High fossil bed site in the City of Fossil and the facilities located on the school grounds.

Fossil School District Board will assume responsibility for the following:

 Represent the Fossil School District in all discussions and negotiations related to the use and development of the district's properties and facilities contained on these properties for the development of the Paleo Project;



- Represent the interests of the School District on the development of an alternative athletic field that will be pursued because of the development of the Paleo Project on the present Wheeler High site;
- When appropriate, represent the school district in develop and or implementation of programs related to the Paleo Project that utilize facilities or properties owned by the Fossil School District;
- Provide representation on the Oregon Paleo Lands Institute Board of Directors; and,
- Assist where possible in the development of funding alternatives that support the Paleo Project and future use of the site and facilities owned by the school district.

# **Wheeler County**




#### North Central Education Service District

# Confederated Tribes of Warm Spring

The Confederated Tribes of Warm Springs have been an active in the Lower John Day Partnership and are a key landowner in Wheeler County. Through funding from the BPA the Tribes have acquired and manage over 40,000 acres of land in the John Day Basin for habitat and salmon restoration of former tribal lands. These lands offer an excellent opportunity to be a living laboratory for studying sustainable land management practices and salmon recovery. The Tribes have offered, under supervision, access to these lands to demonstrate environmental practices to restore natural resources over a large contiguous landscape.

# Oregon Department of Geology and Mineral Industries

The Oregon Department of Geology and Mineral Industries produces maps and reports that can be used by the public and by government to reduce the loss of life and property due to geologic hazards and to manage geologic resources, including water. It helps Oregonians understand and prepare for earthquakes, tsunamis, coastal erosion, landslides, floods, and other geologic hazards.
